## **Position Summary**

The Rural Lands Legislative Advocate will work in a team with our Rural Lands Attorney, Working Lands Engagement Coordinator (WLEC), Communications & Media Relations Manager, Food Systems Program Director, and Deputy Director. The Legislative Advocate will also collaborate with 1000 Friends of Oregon's Farmer Advisory Committee (FAC), 11 affiliate organizations, and other allied organizations, associations, and individuals to guide development of the rural lands legislative and rulemaking agendas on issues of farm, forest, and natural resources. The advocate will work closely with 1000 Friends' contract lobbyist and communications staff.

The work of the Legislative Advocate will be focused primarily in Salem, so the advocate must be able to work in or commute to Salem on a regular basis. The exact location of where the advocate is open for consideration so long as commuting to Salem is realistic.

# **Responsibilities & Scope**

- Draft proposed legislation and administrative rules.
- Prior to and during each legislative session:
  - advocate for the 1000 Friends rural lands legislative agenda, and defend against threats to rural lands;
  - $\circ$  build coalitions to advocate for the 1000 Friends legislative agenda;
  - work with the Working Lands Engagement Coordinator and the Communications Manager to build momentum for, and engagement in, the agenda, specifically targeting 1000 Friends' Farmer Advisory Committee, members, legislators, and persuadable general public. Activities include contributing to 1-pagers, social media messaging, regular legislative

communications to members, speaking engagements, and other similar activities and materials.

- Participate in rules advisory committees, work groups, and other similar activities related to legislation and rulemaking.
- Develop relationships with staff and Commissioners of the Oregon Departments of Land Conservation & Development, Agriculture, Fish & Wildlife, Health Authority, Forestry, Water Resources, and other relevant agencies.
- Build relationships and collaborate with other organizations on shared objectives, including legislation.
- Develop and present, with staff team, training for activists, affiliates, and FAC on substantive and procedural land use issues.
- Respond as appropriate to questions on rural lands from members, activists, and media.
- Support the Working Lands Engagement Coordinator in working with and building communities on rural lands issues.
- Work in close coordination with the Rural Lands Attorney on choosing cases that illustrate and support defense of current policy or the need for modifications to statutes.

- J.D. and experience with legislative advocacy, land use, agricultural and forest policy issues, or environmental law
- Familiarity with land use law and the Department of Land Conservation and Development
