1. [SJR 0234](#) *Reeves, McNally

General Assembly, Confirmation of Appointment- David Crowell, Tennessee Public Utility Commission -

2. [SB 1444](#) *Roberts (HB 0655 by *Howell)

Contractors- As introduced, increases the minimum total project cost amount for which a license as a contractor is required from \$25,000 to \$40,928; ties the minimum total project cost amount to the United States Bureau of Labor Statistics' Producer Price Index by Industry: Building Materials and Supplies Dealers; requires the board for licensing contractors to update the amount at least annually and publish the amount on its public website. - Amends TCA Title 62, Chapter 6.

3. [SB 0554](#) *Gardenhire (HB 0781 by *Butler)

Codes- As introduced, provides that a resolution adopted by a county or municipal legislative body on or after July 1, 2023, to exempt itself from the statewide building construction standards relative to one-family and two-family dwellings expires 150 days, instead of 180 days, following the date of the election for the local legislative body next occurring following the adoption of the resolution. - Amends TCA Section 68-120-101.

4. [SB 1197](#) ***Taylor** (HB 1173 by *Hale, Sherrell)

Insurance Companies, Agents, Brokers, Policies- As introduced, requires an insurer to provide the names of the beneficiaries of a decedent's life insurance policy, the benefit amount under the policy, and other information requested by a funeral director or funeral establishment that contacts the insurer on behalf of the decedent's family. - Amends TCA Title 35; Title 56 and Title 62, Chapter 5.

5. [SB 1109](#) ***Bowling** (HB 0637 by *Barrett, Capley, Fritts, Richey, Martin B, Davis, Todd, Doggett, Raper, Burkhardt)

Employees, Employers- As introduced, requires an employer that requires an immunization as a condition of employment or continued employment to exempt from the immunization requirement a person who files a signed, written statement that the immunization conflicts with the person's religious tenets or practices; prohibits an employer from taking adverse action against a person who files a statement of religious objection. - Amends TCA Title 8; Title 14; Title 37; Title 50 and Title 68.

6. [SB 0394](#) ***Lamar, Campbell** (HB 0738 by *Love)

Health, Dept. of- As introduced, requires the department to collaborate with the bureau of TennCare in order to study existing doula certification programs; requires that a report on the study be provided to the members of the general assembly and to the legislative librarian by December 31, 2023. - Amends TCA Title 4; Title 8; Title 56; Title 63 and Title 71.

7. [SB 0717](#) ***Oliver** (HB 0988 by *Beck)

Landlord and Tenant- As introduced, requires a landlord to provide a tenant with 90 days' notice of termination of tenancy for the purpose of eviction of a residential tenant if the tenant is 62 years of age or older, has paid the tenant's due rent and is not in arrears, and the termination and eviction are to allow for new property development. - Amends TCA Title 29 and Title 66.

8. [SB 0338](#) ***Oliver** (HB 0362 by *Love)

TennCare- As introduced, requires the bureau to conduct an annual review of all medications and forms of treatment for lupus, and services for enrollees with a diagnosis of lupus that are eligible for coverage under the medical assistance program; requires the bureau to solicit and consider input from the public when conducting the annual review; requires an annual report to be made to the general assembly. - Amends TCA Title 4; Title 53; Title 56; Title 63; Title 68 and Title 71.

9. [SB 0390](#) *Oliver, Campbell** (HB 0673 by *Johnson G)**

Employees, Employers- As introduced, enacts the "Tennessee Family Insurance Act." - Amends TCA Title 4, Chapter 21; Title 10, Chapter 7, Part 5 and Title 50.

10. [SB 1043](#) *Campbell** (HB 1231 by *Hemmer)**

Tickets, Admission- As introduced, requires a third-party ticket reseller to disclose specific information related to the cost of a ticket; prohibits such a reseller from preserving more than 45 percent of the tickets that the reseller has as a holdback; specifies that a violation of the disclosure requirements and holdback prohibition is a violation of the Tennessee Consumer Protection Act of 1977. - Amends TCA Title 29; Title 39; Title 47; Title 48 and Title 67.

11. [SB 1523](#) *Campbell** (HB 1434 by *Mitchell)**

Tickets, Admission- As introduced, prohibits a ticket vendor from charging additional fees for the sale of a ticket that exceed 15 percent of the face value of the ticket; requires a ticket vendor to disclose the face value of the ticket, the cost of additional mandatory fees, the cost of additional fees charged by the ticket vendor, and the total cost of the ticket, to the consumer; specifies that a violation constitutes an unfair or deceptive act or practice, subject to penalties and remedies under the Tennessee Consumer Protection Act of 1977. - Amends TCA Title 29; Title 39; Title 47; Title 48 and Title 67.

12. [SB 0138](#) *Hensley, Walley, Swann** (HB 0761 by *Eldridge, Cepicky, Helton-Haynes)**

Consumer Protection- As introduced, enacts the "Youth Mental Health Safety Act." - Amends TCA Title 47, Chapter 18.

13. [SB 0308](#) *Hensley** (HB 0332 by *Cepicky, Sexton)**

TennCare- As introduced, requires the bureau to contract with at least one managed care organization that is partnered with a provider participation entity; establishes eligibility requirements for such entities to contract with TennCare; prohibits TennCare from choosing managed care organizations through a request for proposal or competitive bidding process beginning January 1, 2024; and makes other various changes. - Amends TCA Title 4; Title 56; Title 68 and Title 71.

14. [SB 0548](#) *Lowe, Jackson (HB 0286 by *Baum)

Fireworks- As introduced, permits the sale of fireworks in a municipality or county unless the municipality or county passes an ordinance or law prohibiting the sale of fireworks in the municipality or county. - Amends TCA Title 68, Chapter 104.

15. [SB 0642](#) *Powers (HB 0833 by *Burkhart, Johnson C, Glynn)

Sewage- As introduced, requires an affidavit of affixation for a manufactured home affixed to a parcel of real property to contain a statement that the manufactured home is permanently connected to a functioning septic system, not just a septic system. - Amends TCA Title 39; Title 47; Title 55; Title 66; Title 68 and Title 69, Chapter 3.

16. [SB 0707](#) *Stevens, Yager, Reeves (HB 1010 by *Grills, Williams, Vaughan, Burkhart, Hicks T, White)

Codes- As introduced, lowers the population threshold, from 25,000 to 20,000, below which two or more cities may agree to jointly engage one building inspector. - Amends TCA Title 5; Title 6; Title 7 and Title 68, Chapter 120.

17. [SB 0233](#) *Yarbro (HB 0379 by *Beck)

Professions and Occupations- As introduced, decreases from 15 to 10 the number of days that an unarmed security guard or officer applicant has from the date of employment to complete general training and pass an examination. - Amends TCA Title 29; Title 57 and Title 62, Chapter 35.

18. [SB 0723](#) *Yarbro (HB 0296 by *Freeman)

Codes- As introduced, authorizes a person entering into employment as a municipal or county building, plumbing, mechanical, or electrical inspector with an exempt jurisdiction to perform field inspections as of the date of employment; requires such persons to obtain either a commercial or residential certification, or both, in their respective discipline within 12 months of the date of employment. - Amends TCA Title 68, Chapter 120, Part 1.

19. [SB 1074](#) *Yarbro (HB 1432 by *Dixie)

Insurance, Health, Accident- As introduced, enacts the "Tennessee Preexisting Conditions Protection Act." - Amends TCA Title 56.

20. [SB 1276](#) *Yarbro (HB 1305 by *Thompson)

Landlord and Tenant- As introduced, requires a landlord, or another person authorized to enter into a rental agreement on the landlord's behalf, to disclose to a residential tenant certain contact information for the agent authorized to manage the premises and an owner of the premises, or a person or agent authorized to act for and on behalf of the owner for the acceptance of service of process and for receipt of notices and demands. - Amends TCA Title 66.

21. [SB 0876](#) *Akbari (HB 1396 by *Harris)

Consumer Protection- As introduced, prohibits consumer reporting agencies from including on a consumer report a record of a civil action that is filed in this state, if the action is dismissed or any judgment issued in the action is satisfied. - Amends TCA Title 8; Title 9, Chapter 8; Title 10, Chapter 7; Title 16; Title 18; Title 20; Title 21; Title 27; Title 28; Title 29; Title 45; Title 47; Title 50, Chapter 6 and Title 66.

22. [SB 1260](#) *Akbari (HB 0351 by *Hardaway)

Industrial Development- As introduced, authorizes the establishment of industrial development corporations solely to assist and benefit minority-owned businesses, locally owned businesses, small businesses, and women-owned businesses. - Amends TCA Title 7, Chapter 53.

23. [SB 1263](#) *Akbari (HB 1467 by *Towns)

Workers Compensation- As introduced, permits an injured employee to choose a treating physician in any specialty and makes various other changes related to the selection of treating physicians for injured workers under the Workers' Compensation Law. - Amends TCA Title 50.

24. [SB 1338](#) *Bailey (HB 1211 by *Sexton , Boyd)

Economic and Community Development, Dept. of- As introduced, adds certain requirements for receiving grants under the Broadband Accessibility Grant Program. - Amends TCA Title 4, Chapter 3; Title 7; Title 65 and Title 67.

25. [SB 1296](#) *Bailey (HB 0052 by *Hale)

Surveyors- As introduced, expands notice requirement for land surveyors conducting boundary surveys by requiring them to notify all adjoining landowners of the survey rather than just when the surveyor discovers or reasonably should have discovered discrepancies between the deed descriptions of the adjoining owners. - Amends TCA Title 62, Chapter 18, Part 1.

26. [SB 0650](#) *Johnson (HB 1342 by *Sexton , Vital, Vaughan, Alexander)

Economic and Community Development- As introduced, in order to be designated as a "broadband ready community" by the department of economic and community development, requires a political subdivision to adopt an ordinance or policy for reviewing applications and issuing permits related to projects relative to broadband services that includes a provision that all applications related to a project will be reviewed and either approved or denied within 20 business days, instead of 30 business days, after the application is submitted. - Amends TCA Title 4 and Title 50.

27. [SB 1201](#) *Johnson (HB 1276 by *Boyd)

Contractors- As introduced, specifies circumstances under which a contractor can seek early release of a retainage held by a party with which the contractor has a written contract; makes other changes related to retainages for contractors. - Amends TCA Title 16, Chapter 15 and Title 66.

28. [SB 0122](#) *Niceley, Bowling (HB 0040 by *Reedy, Hulsey, Warner, Vital, Raper, Fritts, Hawk, Capley)

Real Property- As introduced, prohibits foreign ownership of real property in this state by nonresident aliens and foreign entities if the laws of the country where such aliens reside, or such entities are located, prohibit citizens of the United States or its territories or possessions from purchasing real property located within that country. - Amends TCA Title 43; Title 44; Title 47; Title 48 and Title 66.

29. [SB 0368](#) *Niceley (HB 1182 by *Garrett)

Consumer Protection- As introduced, enacts the "Prohibition on Unfair Service Agreements Act." - Amends TCA Title 47, Chapter 18 and Title 66.

30. [SB 0661](#) *Niceley (HB 1306 by *Kumar, Faison, Lamberth, Thompson, Miller, Helton-Haynes, Hale, Hurt, Crawford, White, Martin G, Todd, Capley, Butler, Littleton, Alexander)

Consumer Protection- As introduced, requires an entity that requires on-site payment for services and only accepts payment by quick response code or a credit or debit card machine to accept payment by cash, by check, or through a system that allows the consumer to provide the consumer's credit or debit card information over the phone, or allow the consumer to leave the property without payment at the time, if the quick response code or credit or debit card machine fails to operate correctly to process the payment transaction. - Amends TCA Title 39; Title 47 and Title 48.

31. [SB 0909](#) *Niceley (HB 0693 by *Parkinson)
Employees, Employers- As introduced, prohibits an appointing authority from entering a government employee's private property or residence without written consent from the employee. - Amends TCA Title 8 and Title 50.
32. [SB 0913](#) *Niceley (HB 1136 by *Miller)
Fireworks- As introduced, increases, from two to three days, the permit expiration grace period for a holder of a fireworks permit. - Amends TCA Title 68, Chapter 104.
33. [SB 0914](#) *Niceley (HB 1137 by *Miller)
Fireworks- As introduced, requires the state fire marshal to accept an application for a public display of fireworks, regardless of when the application is submitted, and approve the permit for the display if all other permitting and safety requirements are met. - Amends TCA Section 68-104-211.
34. [SB 1143](#) *Niceley (HB 1373 by *Carr)
Employees, Employers- As introduced, increases from 12 to 24 hours the period a former employee has to withdraw from the premises of the former employer's premises after a separation from employment. - Amends TCA Title 4 and Title 50.
35. [SB 1147](#) *Niceley (HB 1346 by *Powers)
Real Property- As introduced, prohibits this state and its political subdivisions from adopting or implementing policy recommendations that deliberately or inadvertently infringe or restrict private property rights without due process, as may be required by policy recommendations originating in, or traceable to, "Agenda 21," adopted by the United Nations in 1992 at its Conference on Environment and Development or any other international law or ancillary plan of action that contravenes the constitution of the United States or the constitution of this state. - Amends TCA Title 4; Title 5; Title 6; Title 7; Title 66 and Title 68.
36. [SB 0666](#) *Reeves, McNally (HB 0885 by *Hawk, Sexton , White)
TennCare- As introduced, removes a provision requiring the bureau of TennCare to establish a medication therapy management pilot program that terminated in 2020. - Amends TCA Title 53; Title 56 and Title 71.

37. [SB 0677](#) *Reeves (HB 0949 by *Boyd)

Insurance Companies, Agents, Brokers, Policies- As introduced, authorizes a dental service plan corporation to limit participation in a plan that is providing or managing dental benefits for the impoverished uninsured on behalf of, or as required by, any governmental entity, only if such excluded provider is given written notice, the specific reason for such exclusion, and an opportunity for appeal. - Amends TCA Title 4; Title 56; Title 63; Title 68 and Title 71.

38. [SB 0694](#) *Reeves (HB 0186 by *Whitson)

Commerce and Insurance, Dept. of- As introduced, requires the commissioner to make available to healthcare providers on the department's website the prescribed claims forms for reporting by healthcare providers. - Amends TCA Title 8; Title 56; Title 68 and Title 71.

39. [SB 0862](#) *Reeves (HB 1163 by *Todd, Hulsey)

Health Care- As introduced, requires the commissioner of commerce and insurance to make the standardized forms for health care insurance claims, developed by the commissioner along with the commissioner of health, available to insurance companies for free on the department of commerce and insurance's website. - Amends TCA Title 48 and Title 56.

40. [SB 0863](#) *Reeves (HB 0750 by *Powell)

Real Property- As introduced, requires the board of directors for a unit owners' association to have a reserve study done on or before January 1, 2024, if the board has not had a reserve study conducted on or after January 1, 2023; requires the board to have an updated reserve study done within five years of the date that the reserve study is done, and every five years thereafter. - Amends TCA Title 66, Chapter 27.

41. [SB 0866](#) *Reeves (HB 0827 by *Sparks)

Hospitals and Health Care Facilities- As introduced, requires the call button to each bed in a general patient area in a nursing home to be easily reachable to, and useable by, a patient. - Amends TCA Title 33; Title 56; Title 63; Title 68 and Title 71.

42. [SB 1358](#) *Southerland, Rose (HB 0943 by *Alexander)

Utilities, Utility Districts- As introduced, requires franchise holders, and certificated providers, that provide broadband service to file on or before July 1, 2023, and by July 1 of the two subsequent years thereafter, a map or other information with the appropriate regulatory entity indicating the specific locations where the provider offered broadband service that is capable of delivering download speeds of at least 100 Mbps and upload speeds of at least 20 Mbps. - Amends TCA Title 7 and Title 65.

43. [SB 1377](#) ***Southerland** (HB 0799 by *Zachary, White)
Codes- As introduced, requires that the 2018 International Energy Conservation Code published by the International Code Council be used for the minimum energy conservation standards for new residential construction. - Amends TCA Title 4, Chapter 3; Title 13, Chapter 19 and Title 68, Chapter 120.
44. [SB 1379](#) ***Southerland** (HB 0965 by *Fritts)
Banks and Financial Institutions- As introduced, prohibits a financial institution from releasing or providing the account balance or transaction activity of an account to a person without first obtaining the account holder's express permission or without a warrant issued by a judicial officer located in this state. - Amends TCA Title 45 and Title 47, Chapter 18.
45. [SB 1170](#) ***Swann** (HB 1457 by *Cochran)
Professions and Occupations- As introduced, increases the length of notice the executive director of the board must give a person holding a current licensure registration to practice as a professional or registered nurse that the renewal fee is due, from 60 days to 65 days prior to the due date of the renewal fee. - Amends TCA Title 4; Title 33; Title 49; Title 53; Title 55; Title 56; Title 63; Title 68 and Title 71.
46. [SB 1299](#) ***Bailey** (HB 1504 by *Fritts)
Consumer Protection- As introduced, requires a social media platform to provide certain information about its content and data management, business practices, and acceptable use policy; prohibits a social media platform from censoring the expression of a user who resides in this state based on viewpoint or geographic location; imposes other related requirements and prohibitions. - Amends TCA Title 4; Title 47 and Title 65.
47. [SB 1294](#) ***Bailey** (HB 1309 by *Kumar)
DNA and Genetic Testing- As introduced, prohibits a life insurance provider from canceling a life insurance policy based on genetic information, from requesting or requiring genetic testing as a condition of insurability, and from accessing the genetic data of an individual without consent. - Amends TCA Title 56, Chapter 7, Part 27.
48. [SB 1295](#) ***Bailey** (HB 1310 by *Kumar)
Consumer Protection- As introduced, enacts the "Genetic Information Privacy Act." - Amends TCA Title 47.

49. [SB 0073](#) *Watson (HB 1181 by *Garrett)

Consumer Protection- As introduced, enacts the "Tennessee Information Protection Act." - Amends TCA Title 4; Title 12; Title 43; Title 45; Title 47; Title 48; Title 50; Title 61; Title 66 and Title 67.

50. [SB 0111](#) *Watson, Bowling (HB 0682 by *Powers)

Common Carriers- As introduced, designates social media platforms as common carriers and requires the entities to obtain certificates of public convenience and necessity from the Tennessee public utilities commission; prescribes fines against social media platforms that deplatform and shadow ban users based on political ideology, viewpoint, or personal animus, or discrimination based on race, creed, color, religion, sex, age, or national origin. - Amends TCA Title 4; Title 47 and Title 65.

51. [SB 0460](#) *Watson (HB 0607 by *Hale, Lynn, Clemmons)

Insurance, Health, Accident- As introduced, lowers from five business days to four business days, the time from the receipt of a request for more information from a utilization review agent within which the agent must notify the enrollee and the provider or healthcare facility in writing, or through email or respective electronic portals, of the additional information needed to make the determination on a request for prior authorization. - Amends TCA Title 56 and Title 71.

52. [SB 0502](#) *Watson (HB 0916 by *Rudder)

TennCare- As introduced, extends, from January 15 to February 1 of each calendar year, the due date of the annual report required to be submitted by the bureau of TennCare to certain legislative committees on the use and cost of opioids and other controlled substances in the prescription drug program for the TennCare program. - Amends TCA Title 4; Title 56 and Title 71.

53. [SB 0850](#) *Watson (HB 1263 by *Travis)

Labor- As introduced, requires the department of labor and workforce development to conduct a study of the Child Labor Act of 1976 and the Tennessee Protection of Minor Performers Act, and to report its findings to the governor, the speaker of the house of representatives, the speaker of the senate, and the legislative librarian no later than December 1, 2023. - Amends TCA Title 4 and Title 50.

54. [SB 1345](#) *Watson, Hensley, Briggs, McNally, Reeves, Crowe, Lowe, Jackson (HB 1503 by *Vaughan, Rudder, Sexton, Hawk, Garrett, Davis, Terry, Lamberth, Alexander, Helton-Haynes, White)

Insurance Companies, Agents, Brokers, Policies- As introduced, enacts the "Surprise Billing Consumer Protection Act"; makes changes to law regarding network adequacy of managed health insurance issuers. - Amends TCA Title 8; Title 56; Title 63 and Title 68.

55. [SB 1404](#) *Watson (HB 1001 by *Helton-Haynes)

TennCare- As introduced, adds the legislative librarian as a party to whom the bureau must send a copy of its annual report that describes the nature and purpose of requests to utilize data from the all payer claims database that were submitted to the bureau or the health information committee. - Amends TCA Title 4; Title 56; Title 68 and Title 71.

56. [SB 0996](#) *Yager (HB 0846 by *Fritts)

Internet and -Commerce - As introduced, prohibits an online payment system from freezing the funds of a user without first providing the user with a 90-day written notice of the online payment system's intent to freeze the user's funds; designates a violation as an unfair or deceptive act or practice pursuant to the Tennessee Consumer Protection Act of 1977. - Amends TCA Title 45 and Title 47, Chapter 18.

57. [SB 1283](#) *Bailey (HB 1066 by *Boyd)

Economic and Community Development- As introduced, requires that a broadband ready community's ordinance or policy for reviewing applications must contain a provision that all applications related to the project be either approved or denied within 30 calendar days, rather than 30 business days, after the applications are submitted. - Amends TCA Title 4.

58. [SB 1284](#) *Bailey (HB 1061 by *Vaughan)

Commerce and Insurance, Dept. of- As introduced, removes references to repealed provisions of law that provided an additional definition of contractor, and additional penalties, in relation to unlawful representation as a licensed contractor. - Amends TCA Title 4; Title 5; Title 6; Title 7; Title 12; Title 13; Title 42; Title 43; Title 44; Title 45; Title 46; Title 47; Title 48; Title 50; Title 53; Title 54; Title 55; Title 56; Title 61; Title 62; Title 65; Title 66; Title 67; Title 68 and Title 71.

59. [SB 1285](#) *Stevens (HB 1060 by *Boyd)

Employees, Employers- As introduced, removes a provision that required the department of labor and workforce development to report by January 1, 2014, to the commerce and labor committee of the senate and the business and utilities committee of the house of representatives concerning the department's findings and recommendations concerning the Tennessee works pilot program. - Amends TCA Title 8; Title 50; Title 62; Title 63 and Title 68.

60. [SB 1286](#) *Bailey (HB 1062 by *Vaughan)

Financial Institutions, Dept. of- As introduced, removes a reference to a repealed provision of law that required state banks and certain securities broker-dealers to adhere to certain disclosure requirements of the federal deposit insurance corporation. - Amends TCA Title 4; Title 39; Title 45; Title 47 and Title 48.

61. [SB 1287](#) *Bailey (HB 0188 by *Kumar)

Insurance Companies, Agents, Brokers, Policies- As introduced, removes a reference to a repealed provision of law that established an exception to the prohibition of managed health insurance issuers contacting or employing an agent to directly contact a patient of a physician's practice in an effort to change a referral for services to another provider if the managed health insurance issuer has contracted with the physician directly. - Amends TCA Title 4; Title 7; Title 8; Title 10; Title 33; Title 45; Title 47; Title 49; Title 50; Title 53; Title 55; Title 56; Title 62; Title 63; Title 65; Title 68 and Title 71.

62. [SB 1288](#) *Bailey (HB 1065 by *Boyd)

Workers Compensation- As introduced, extends from December 31 to January 1, the date by which the bureau of workers' compensation must produce its annual report listing the name of each covered employer that failed, during the preceding state fiscal year, to provide workers' compensation coverage or qualify as a self-insured employer as required by law. - Amends TCA Title 4; Title 50, Chapter 6 and Title 56.

63. [SB 1290](#) *Bailey (HB 1196 by *Williams)

Labor and Workforce Development, Dept. of- As introduced, requires the commissioner to ensure that a listing is made available to the public on the department of labor and workforce development's public website of apprenticeship programs that are mandated by state or federal law due to the program sponsor receiving funds or resources from the state or federal government and that are approved by the office of apprenticeship; requires the listing to be updated no less than twice annually. - Amends TCA Title 4; Title 50; Title 62 and Title 67.

64. [SB 1292](#) *Bailey (HB 1420 by *Butler)

Commerce and Insurance, Dept. of- As introduced, increases the base salary of certain categories of preferred service employees of the department. - Amends TCA Title 4; Title 8; Title 47; Title 48; Title 56 and Title 68.
