The Public Members will be appointed by six members of the SamTrans board - the three members appointed by the Board of Supervisors and the three members appointed by the City Selection Committee. The seat will fill a partial term through December 31, 2024.

The SamTrans Board of Directors was formed in 1976 to meet the public transit needs of the County. The Board consists of nine members: three members appointed by the Board of Supervisors, two of whom are members of the Board of Supervisors and one who possesses expertise in the field of transportation; three members appointed by the City Selection Committee, who are council members at the time of their appointment; and three public members, one of whom is a coastal resident.
