

Requesting reasonable accommodations and weighing the decision to potentially disclose one's disability to an employer can be intimidating and even a little scary. Many people have questions about disclosing their disability and how this may impact them. The good news is disclosure can be a simple process. Often people do not need to label themselves with a disability to advocate for reasonable accommodations that can help people succeed in the workplace and benefit both the employee and the employer. The Americans with Disabilities Act (ADA) requires employers to provide qualified disabled applicants and employees "reasonable accommodation," but provides minimal guidance. This presentation will look at the Who's, What's, When's, Where's, Why's and importantly the How's of requesting a reasonable accommodation from an employer under the Americans with Disabilities Act (ADA).

Housing Affordability is a complex issue involving federal, state, and local housing policy decisions and funding. In Virginia, there is currently a shortage of at least 200,000 affordable homes. Further, just 1 out of 4 households that qualify for assistance receive it due to a lack of funding. This session will provide an overview of the current affordable housing environment and outline available resources.

Transportation Navigator is a free online resource to help connect people with transportation options in Virginia. The Virginia Department of Rail and Public Transportation collaborated with Virginia Navigator to develop resources that help make it easier for people to search for transportation providers and identify a service to meet their needs. Brittany Voll with DRPT will give an overview of the resource and discuss ways that individuals and families can use it to navigate public and human services transportation in Virginia.

Four main areas will be covered within this panel:

**Social security disability benefits** can be received until one reaches their full retirement age. Learn how you can parley this benefit with your Social Security retirement benefits for maximum financial and healthcare security.

The Program of All-inclusive Care for the Elderly (PACE) was established to help adults ages 55+ who are living with chronic healthcare needs or disabilities by providing community-based healthcare services and supports. By providing flexibility in how participants' healthcare needs are met, PACE is often able to help people reside within their own homes and communities longer than would have otherwise been possible.

The Department for Aging and Rehabilitative Services' Office of the State Long-Term Care Ombudsman has independent Medicaid Managed Care Advocates to help with information and problem solving for individuals who are enrolled in Medicaid Managed Care. The Advocate team assists with benefits access, facilitation of communication with Managed Care plans, and support filing grievances and submitting appeals when benefits have been reduced or denied.

The presentation will provide a background of the **SHIP/VICAP program** and the services that we offer to Virginia's Medicare beneficiaries.
