Position Overview: The Shiver Center on Poverty Law is seeking a Director of Housing Justice to provide organizational leadership and management oversight of the its work to ensure that people living in poverty, communities of color, and members of other protected classes have access to safe, decent, and affordable housing, and that the systems and structures that create and sustain racial segregation and markedly different outcomes for communities based upon their racial makeup are dismantled. The Director of Housing Justice supervises a team of lawyers to advance equitable housing laws and policies for all in Illinois, nationally through the Shriver Center on Poverty Law's national networks, and at the federal level through select projects. The Director of Housing Justice ensures that the advocacy of the team is community-driven and with direct community input. The Director of Housing Justice also participates in the formation and strategy of coordinated multi-state advocacy campaigns, which could include litigation, legislative, and administrative advocacy strategies, and helps to form and manage interactions and coordinated projects with other local, state and national networks. The Director of Housing Justice is also responsible for program and staff evaluations, including collecting data and information and implementing appropriate program adjustments.

## **Responsibilities:**

- Provides strategic leadership on the housing law and policy efforts of the Shriver Center on Poverty Law by providing program direction and contributing to the development and implementation of strategies, plans, and goals.
- Provides guidance and active supervision to attorneys, program associates, interns and volunteers to ensure they have the skills and tools necessary to advance the Shriver Center on Poverty Law's housing justice agenda.
- Promotes and facilitates relationships with current and potential partners and represents
  the Shriver Center on Poverty Law in local, state and national coalitions, working groups,
  commissions and task forces.
- Leads the policy and administrative advocacy agenda on housing justice issues at the local, state, and national level and ensures the advocacy agenda is community-driven and with direct community input.
- In consultation with the Senior Director of Litigation, advances systemic litigation and represents clients as appropriate.
- Collaborates with the communications department to engage in media and public relations campaigns to advance the advocacy agenda and serves as Shriver Center on Poverty Law spokesperson on housing justice advocacy positions.
- Collaborates with the Shriver Center on Poverty Law's multi-state networks and other local, state and national networks and allies to support housing justice agenda.
- Serves as a strategic partner to the development team in fundraising efforts for the housing justice programs, including proposal preparation, budgeting and reporting.
- Collaborates with the advocacy resources and training department to support training opportunities for advocates.
- Evaluates the progress of the housing justice team consistent with team and organizational goals.
- Travels in Illinois and national conferences and meetings as needed.

## **Qualifications:**

- Licensed to practice law with a minimum 5 years legal experience.
- Experience and expertise with public and assisted housing programs, fair housing, healthy housing, tenants' rights and related advocacy.
- Demonstrated commitment to and success advancing advocacy campaigns on the legal and policy issues affecting people living in poverty and communities of color, including experience litigating, lobbying, and working with community organizers and the media, and other aspects of issue campaigns.
- Ability to motivate and experience managing diverse groups of people; ability to work well as a team member while also holding team members accountable.
- Self-direction and self-motivation, creative in problem solving, and the ability to work collaboratively and independently.
- Willingness and ability to travel as needed (est. 20%).
- Complex litigation experience strongly preferred.
- Fundraising experience preferred.
- Multilingual skills are a plus, but not required.
